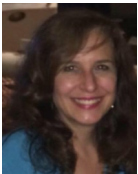
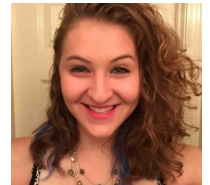


**ARTISTIC DIRECTOR & CHOREOGRAPHER - JOEY FARGÁR**
